

3% almonds, pure butterfat (milk), whole milk powder, oat flakes, egg white, skimmed milk powder, sweet whey powder (milk), low fat cocoa powder, wheat starch, wholemeal wheat flour, invert sugar syrup, dextrose, 0,5% rasped coconut, glucose syrup, emulsifiers: lecithins (contains soya), mono- and diglycerides of fatty acids; 0,3% hazelnuts, vegetable oils (rapeseed, sunflower), salt, lactose (milk), natural flavouring, dried egg white, whole egg powder, raising agents: sodium carbonates, diphosphates, ammonium carbonates; rice starch, baker's honey, coffee powder, egg yolk, dried egg yolk, colouring foodstuff: radish, apple, lemon, safflower, spirulina, carrot, blackcurrant; cream powder (milk), caramel sugar syrup, vanilla extract, thickener: gum arabic; glazing agents: carnauba wax, beeswax, white and yellow.
